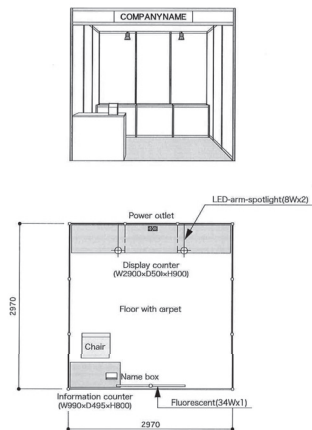

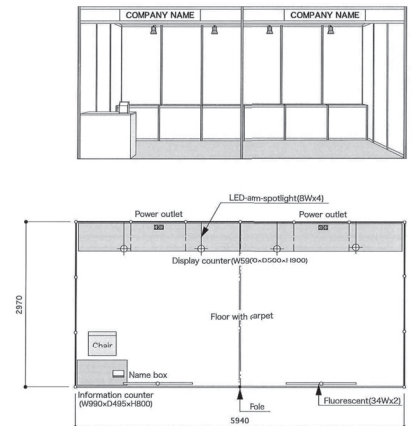

### Booth fee

### Expenses included in booth fee

- Venue usage fee within specified time

- Cost of creation of invitation tickets, etc. and PR costs
- Equipment costs for exhibited products / New technology presentation session
- Operating costs, security fees

### Construction expenses borne by exhibitor

#### Water supply drainage and air

Supply of drainage of water and air can be provided. (Paid service)

### Prohibition of spot sales

**Exhibits for the purpose of spot sales are prohibited.**

If it is discovered that there have been spot sales after the opening of the exhibition, the exhibit will be withdrawn and the exhibition booth fees will not be refunded.

### Cancellation of exhibits

**It is not possible to cancel or reduce the number of booth lots after the exhibit application.**

In the event of cancellation or reduction of the number of booth lots due to unavoidable circumstances, an exhibitor booth fee equivalent to the number of booth lots applied for will be charged as a penalty.

### How to apply

Please fill out the application form on the reverse and send it to the secretariat.

### Deadline for applications

**May 15 (Tue.), 2018**

However, applications will be closed when the scheduled number of booth lots reached, even if before the deadline. If it is difficult to hand in application form by May 15 due to internal procedure, please contact the secretariat.

### Method of payment of exhibition booth fee

After the application form arrives at the secretariat, an invoice will be issued for the exhibition fee,

### Allocation of booths

Allocations will be decided by the organizer and announced to exhibitors in June 2018.

### Bringing in and taking out of exhibits

■ Bringing in: September 24 (Mon.) and 25 (Tue.) 9:00 - 17:00

■ Taking out: September 28 (Fri.) 17:00 - 20:30, same day removal

The secretariat cannot assist in getting exhibitors' shipments cleared through Japan Customs if they are shipping exhibits from outside Japan. We encourage to use a professional freight forwarder, which has some experience in shipping for foreign exhibitions from their countries to Japan.

### In the event of cancellation of the exhibition

If the exhibition is forced to be closed due to circumstances beyond the organizer's control, there are cases where booth fees already paid in may not be refundable.

Other details will be provided in the exhibition manual.
